I. Introduction

The project "Skills Development in the Wastewater Sector of Kosovo" aims to contribute to the capacity development in Kosovo's water and wastewater sector. To reach this goal VSA and SHUKOS act together and work on the organisational development of SHUKOS and its surroundings as well as on the direct capacitation of wastewater experts in Kosovo.

One of the activities aim at the extension of SHUKOS towards an association, which represents all stakeholders of the water and wastewater sector. For this purpose, the extension of SHUKOS with new members was already integrated in the strategic plan for the period 2021-2025. VSA should support this process on the one hand with the delivery of internal processes and regulations as model for the creation of SHUKOS's standards. On the other hand, VSA experts should support the dialogue process between SHUKOS staff and board members, as the execution of the concerning strategic goals seemed to be blocked due to different opinions within the different organisational units.

Considering that SHUKOS has already received the approval of the board for membership expansion, it is necessary to prepare two written documents based on the experience gained from VSA. Documents that will be developed by the engaged local expert are:

- Financial methodology
- How to become a member

II. Scope of Work

The scope and focus of the assignment are the preparation **financial methodology** and a brochure **How to become a member of SHUKOS.**

Financial methodology:

- To prepare the methodology for calculating fees for new categories of membership;
- To prepare the plan for the number of new members during 2023;

- To describe the benefits of being a member for each membership category;
- To add into the SHUKOS website the possibility to become a member directly;
- Describe the payment methodology.
