#### I. Introduction

The project "Skills Development in the Wastewater Sector of Kosovo" aims to contribute to the capacity development in Kosovo's water and wastewater sector. To reach this goal VSA and SHUKOS act together and work on the organisational development of SHUKOS and its surroundings as well as on the direct capacitation of wastewater experts in Kosovo.

Since the strengthening of SHUKOS is one of the main goals of this project, one of the activities is aimed for developing a position paper to support SHUKOS in becoming a competent center for providing wastewater trainings in the future. In the framework of this activity, SHUKOS has carried out other supporting activities:


- Exchange and adaptation of VSA documents based on the needs of SHUKOS

In this context, SHUKOS is seeking to engage a qualified and experienced advocacy expert to develop one position paper / policy recommendation based on the experience gained from the VSA visit in Switzerland to make SHUKOS the only competent centre for providing training in the water and wastewater sector in Kosovo.

- To get acquainted with the topic defined by SHUKOS and to give proposals for the way of developing of position paper;
- To make a research of the education system in Kosovo and identification of options / solutions how

- Prepare the draft of position paper with the contents as below:
  - a. Introduce possible objections and / or oponents of position paper;
  - b. Written in a way that catches the reader's attention;
  - c. Each paragraph **should** present an idea or main concept that clarifies a portion of the **position statement** and is supported by evidence or facts;
  - d. Summarize argument and restate the position on the topic.
- Participate in meeting to discuss on the first draft of the Position Paper and adjustments needed.
- Developing of Position Paper with the criteria as follow:
  - e. Introduction
  - f. Problem History
    - i. Background of the problem
    - ii. Status
  - g. Propose of Position Paper
  - h. A clear Statement
  - i. Conclusion and Recommendations
  - j. Communication / Advocacy Plan
- Presenting the position paper during SHUKOS Board Meeting.




